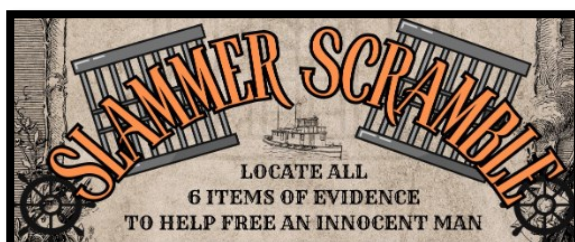
As we wrap up Fiscal Year (FY) 2023/2024, kudos to all involved on a job well done.

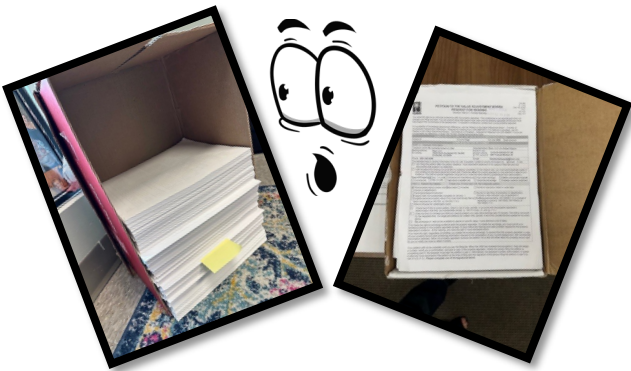
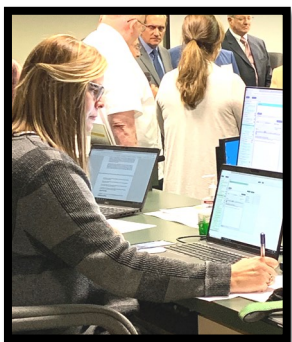

Did You Know.....

....it is property tax petition season and our clerks play a huge role in the annual Value Adjustment Board (VAB) process. This includes Clerk Christine Blanchett with help from Angie Haggard under the direction of Chief Administrative Officer Rick Dingle. The VAB serves as the decision-maker when there is disagreement between a property owner and the Property Appraiser concerning a property’s exemptions, valuations, portability decisions, or change of ownership. The board comprises two county commissioners, a school board member, two citizens, and a local attorney. While we highly encourage property owners to file their petitions online using a link on our website, some still choose to file in-person with hard-copy forms which require staff to do extensive manual entry — more than 1,900 forms this year alone. Kudos to Christine and to Angie (with extra help from Victoria Marquart, Christy Bell, and Stacie Towns) to get this laborious task accomplished!
